## EastArk Secondary Career Center

A student admitted under EastArk Secondary Career Center (ESCC) “concurrent enrollment” admission is one who is currently enrolled in high school, grades 11 -12, and enrolling for classes under a specified program of study. Student must contact high school counselor for participating in the ESCC. Students must have a 2.0 GPA or better and no discipline problems in order to enroll in an ESCC available, approved program of study through the Arkansas Department of Career Education.

The following documents must be submitted to ESCC:

1. A completed Application for Admission at [eacc.edu](http://eacc.edu) **(new students only)**
2. A completed and signed ESCC Enrollment form **(must be submitted both fall and spring semesters.)**
3. A completed “Release of Information” form **(must be completed by the NEW student)**
4. A copy of current high school transcript **(must be submitted each fall semester or new students in the spring)**
5. A copy of shot records **(must be submitted each fall semester or new students in the spring)**
